- 6. Dumping Trash in vacant lots in Cinnamon Homes is strictly prohibited (Reminder requested by President)

  - c. Do not under any circumstances leave trash in property that does not belong to you.
    Bulk trash will be picked up monthly in front of <u>your</u> home on the 2<sup>nd</sup> Wed of Each Month.
- 7. Parking is an ongoing problem. There are only so many parking spots in our community. <u>Parking on the street public right-of-way is prohibited</u>. If there is no place for your vehicle to park in our community then you need to park it OUTSIDE of the COMMUNITY. This is so important I will include the full text from Miramar City Ordinance: (*Reminder by Board*)
  - a. Sec. 20-48.(D) Parking regulations, all zoning districts.
  - b. **Para (D):** *Parking in public right-of-way.* It shall be a violation for any person to park a vehicle on any street in such a way to impede the free flow of traffic or interfere with the passage of emergency vehicles.
  - c. Parallel parking on street in front of your home is parking in the public right-of-way.
